## **EXPLANATIONS:**

Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Consulting, Contracted Services, Staff Development & Related (Supplemental) for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Eaton Corporation could not agree to the Terms and Conditions and were therefore not considered for award. Frontera Refrigeration did not submit the required information to meet the evaluation criteria and were therefore not considered for award. ENCON International, Inc., ESL International, LLC, Manges Consulting, LLC, Shmoop University, Inc., Sirius Education Solutions (Sirius Education Solutions LLC), Storytellin' Time (Mary Jo Huff) and True North Consulting Group, LLC are all currently awarded on a contract(s) and were therefore not considered for award. Going Merry Inc (Charles Maynard) and VeriNova, LLC (Diane Sheline) submitted a response to Bid Line Item #2 (percent discount line) however were not considered for award of that line; vendors failed to submit a pricelist/catalog per solicitation instructions. The Outsource Connection was removed from award due to being awarded on a contract that was a better fit for the services they provide. Going Merry Inc (Charles Maynard), Intervene, and Invo HealthCare Associates LLC were removed from award; vendors were delinguent on reporting and/or administrative fee payment, Committee for Children, Footsteps2Brilliance Inc., Kids Excel El Paso Inc., and Lakeshore Learning Materials LLC (Lakeshore Parent LLC) were awarded a recent contract and therefore removed from this bid award. Alboum Translation Services (Alboum & Associates LLC), Irma Gonzalez LPC, Pasitos Clinic LLC, and Rio Grande Therapy Group (RGTG, LLC) were awarded a recent contract and therefore removed from this bid award. ELL Made Simple (Desiree Marks-Arias dba Marks and Moersch Consulting LLC), Enterprise Risk Management LLC (Guadalupe Rodriguez), Frontera Music Therapy LLC (Corinne Marie-Woolley Richards), and The Modern Classrooms Project Inc. were removed from award for failure to submit insurance as per the bid requirements. US Tech Solutions, Inc. did not want to extend the contract renewal and was therefore removed from award. JDC Energy Resource, LLC (DeMarco Wren) was removed from award for failure to submit insurance as per the bid requirements. Inspiration Motivation Application LLC (Aurora Anaya- Dyer) and Scholastic Inc. were awarded a recent contract and therefore removed from this bid award. EDU Specialist LLC, KH Literacy Education LLC (Kristen Leanne Henry), and vTech Solution Inc were removed from award for failure to submit insurance as per the bid terms. SRB Consulting & Design LLC was awarded a recent contract and therefore removed from this bid award. Green Light Group Tours (Grand Fund, Inc.) was awarded a recent contract and therefore removed from this bid award. Houston Education Leadership Partners (Houston Education Leadership Partners, LLC) was awarded a recent contract and therefore removed from this bid award a recent contract and therefore removed from this bid award.
