**EXPLANATIONS:**

Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Consulting, Instructional, and Training Resources (Supplemental) for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Accelerate Learning Inc., Asteria Education Inc. dba ECS Learning Systems, Bedford, Freeman & Worth Publishing Group LLC, Bellwether Media, Complete Book and Media Supply LLC, friEdTechnology, Hatch Inc, Learning Farm LLC, Learning Without Tears (No Tears Learning), New Horizons Learning LLC dba New Horizons, Okapi Educational Publishing, Progress Learning LLC, Real OT Solutions Inc., Rev it Up! Consulting Group (Rev it Up! Consulting Group, LLC), Scholastic Book Fairs, Seidlitz Education, Think Big Learning, and Ztastic Solutions LLC submitted a proposal however were not considered; vendors are already awarded on an existing consulting contract. Scenario Learning DBA Vector Solutions, and Southwest Plastic Binding Company dba Southwest Binding & Laminating submitted a proposal however were not considered; vendors are already awarded on an existing contract that is a better commodity fit. Assessment Intervention Management LLC, Century Resources LLC, Citygovapp Inc, Gillem Staffing (Gillem Speech - Language Pathology Services LLC), GSFT - School Safety Certification (Go Strapped Firearms Training LLC), LSH Furniture LLC (LS Office Furniture), MaxiAids Inc., Tuatara Consulting Inc., and WesTX School Based Psychological Services submitted a proposal however were not considered; vendors do not meet the scope of work. Franklin Covey Client Sales Inc. and Pluralsight LLC withdrew their submittals. ETA hand2mind (hand2mind, Inc.) submitted a proposal however was not considered; vendor was terminated for failure to pay administrative fees and/or report sales and is ineligible to bid at this time. Catapult Learning (Catapult Learning West, LLC), Paul H. Brookes Publishing Co. Inc., and Perfection Learning Corporation submitted a proposal however were not considered; vendors are delinquent on reporting and/or administrative fee payment. Benchmark Education Company LLC, Nasco (Nasco Education LLC), and The Awareness & Compassion Project were removed from award for failure to submit insurance as per the bid terms. J. Chad Professional Training LLC requested to retract their bid submittal; bid has been amended accordingly. Active Parenting Publishers and Cambridge University Press (The Chancellor, Masters, and Scholars of the University of Cambridge) were removed from award for failure to submit insurance as per the bid terms. ChildPlus Software (Management Information Technology USA Inc) and PSNI LLC were awarded a recent contract and therefore removed from this bid award. Schoolhouse Educational Services, Inc. was terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Kishmorr Productions LLC is no longer in business and has therefore been removed from award. Class Companion was terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Aloe Software Group LLC was awarded a recent contract and therefore removed from this bid award. Learning Plus Consulting, Inc is no longer in business and was therefore removed from award.
