ACO Remodeling & Construction Inc. withdrew their submittal. Black Stallion Construction, Inc. and Goytia Enterprises Company submitted a proposal however were not considered; vendors do not meet the scope of work. Lariat Builders Group Corp submitted a proposal however was not considered; vendor is not current with reporting and/or administrative fee payments, as per the bid terms. SERVPRO of Amarillo (MBW SERV Corporation) was removed from award at the vendor's request.
