Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Advertising, Graphic Design, Marketing Services and Related for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Adams Consulting Tower LLC (Nekita Adams) submitted a proposal however was not considered; vendor does not meet the scope of work. Display Services Inc submitted a proposal however was not considered; vendor was terminated and is ineligible for a new contract at this time. Alby.Design (Alberto Bordier) and inSegment were removed from award for failure to submit insurance as per the bid terms. Barracuda Public Relations is no longer in business and was therefore removed from this bid award.
