EXPLANATIONS:

Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Guidance and Counseling, Mental Health Support, Intervention, and Therapy Services for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Adams Consulting Tower LLC, Gerry Brooks (Gerald A. Brooks Jr.), and Studiously (Granthropology LLC) submitted a proposal however were not considered; vendors do not meet the scope of work. E-Therapy Intermediate, Inc. submitted a proposal however was not considered; vendor is already awarded on an existing guidance and counseling contract. Gaggle.Net, Inc. submitted a proposal however was not considered; vendor's proposed deviations were not acceptable. Applied Pediatrics Inc submitted a proposal however was not considered; vendor did not meet the bid requirements. Tranquil Minds Behavioral Health (Tranquil Minds Behavioral Health LLC) was removed from award for failure to submit insurance as per the bid terms. Family Endeavors, Inc. (dba Endeavors), Girasol Support Services, Sigma Resources LLC, SpringHealth Behavior Health & Integrated Care Texas (SpringHealth Integrated Care, Inc.), and The Tallest Trees LLC. were removed from award for failure to submit insurance as per the bid terms. Neuro Therapy Systems PLLC was removed from award for failure to submit insurance and for failure to report/pay administrative fees as per bid requirements. Desert Star Therapy LLC provided their MWBE certification; updated accordingly.
