Evaluation and award recommendation were based on 70% pricing and 30% references. Accelerate Learning Inc., Agape Therapies & Educational Services, Amira Learning, Inc., Ascend Education (KMB of Shreveport, L.L.C.), Assessment Intervention Management, LLC, Axiom Learning, Inc., Betters-Bubon Consulting (Betters Bubon Educational Consulting, LLC), Beyond Therapy Educational Solutions, Christal Vision, Complete Book and Media Supply, LLC., Discount School Supply (Earlychildhood LLC), K12 Coalition (Learners Edge, LLC), KAMICO Instructional Media, Inc., Kaplan Early Learning Company, Lakeshore Learning Materials, LLC (Lakeshore Parent, LLC), Learning Without Tears (No Tears Learning), Medicaleshop Inc., National Recruiting Consultants, Parallel Learning Behavioral Health P.C., Paul H. IDR Healthcare, LLC. was recently awarded on another contract that is a better commodity fit; therefore, removed from this award.
