## EXPLANATIONS:

Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Event Center Products, Services and Related for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. A to Z Notary, Chaplaincy and Consultancy Services (Skeete, Vibert DBA A to Z Notary, Chaplaincy and Consultancy Services), El Senor Cantarito (Clay and Fun LLC), Mano Wine & Spirits LLC, Mena Photography (Alan Mena), and PepWear LLC were removed from award for failure to submit insurance as per the bid requirements. Creative Print Plus (Estela Martinez) was removed from award for failure to submit insurance as per the bid requirements; however later obtained the required insurance and therefore earned back their award. Freedom Rhythm PLLC submitted a proposal however was not considered; vendor withdrew their submittal. Glowforge Inc. submitted a proposal however was not considered; vendor's proposed deviations were not acceptable. Arspec Inc and L&L Special Systems LLC submitted a proposal however were not considered; vendors withdrew their submittal. Us Foods (Us Foods Inc.) submitted a proposal however was not considered; vendor did not meet the bid requirements. US Foods (US Foods Inc.) later submitted all documents needed to meet the bid requirements and was therefore considered for award; bid has been amended accordingly. Spartan Medical Protection (MAC Entertainment Management, LLC) no longer provides services and was therefore removed from award. Immigr8 Inc. submitted a "No Bid" response. PeopleReady Inc. submitted a proposal however was not considered; vendor's proposed terms were not acceptable. PeopleReady Inc. then withdrew their terms and earned an award; award summary has been amended accordingly. Sun City Border LLC (Taquizas Los Pistoleros) submitted a proposal however was not considered; vendor did not meet the bid requirements.
