1. Meet with ESC personnel to determine scope of work, including on-site visits as necessary, and provide a written scope of work for approval to the Director of Facilities, Maintenance, Transportation and Support.
2. Provide a preliminary design concept for approval if necessary. Preliminary design should be received in a timely manner as agreed upon by the vendor and ESC staff.
3. Prepare preconstruction documents and final documents for construction. If construction is being bid in house, vendor will provide electronic bid documents to purchasing for review, approval and posting at least 1 week before bid is to be issued.
4. Provide all necessary construction support to include but not limited to: on site visits, weekly construction progress reports, clarification of plans, issuance of certificates for completion, warranty work, etc.
