Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Consulting, Instructional, and Training Resources for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. 240 Tutoring Inc., Barnes & Noble Booksellers Inc., Bookelicious LLC, Condor Consulting Group LLC, Constructive Playthings (U.S. Toy Company, Inc.), Crowning Point LLC, Istation (Imagination Station, Inc.), Learning Farm LLC, Okapi Educational Publishing, Subject Technologies Inc, and Wink Educational Consulting, Inc. submitted a proposal however were not considered; vendors are already awarded on an existing consulting contract. Lilliworks Active Learning Foundation and School Life (imagestuff.com, inc.) submitted a proposal however were not considered; vendors are already awarded on an existing contract that is a better fit for their company. Adams Consulting Tower LLC (Nekita Adams), Agape Therapies & Educational Services, Assessment

Intervention Management LLC, Blue Heron Consulting Corporation (BHC Global), Century Resources LLC, National Recruiting Consultants, Oscar A Reyes Med,LPC,PLLC, Soliant Health, Stuttering Therapy Services and Seminars, and Tuatara Consulting Inc. submitted a proposal however were not considered; vendors do not meet the scope of work. Young Rembrandts (Creart Inc) submitted a proposal however was not considered; vendor was terminated and is ineligible for a new contract at this time. Frog Street Press submitted a proposal however was not considered; vendor did not meet the requirements of the bid regarding reporting and/or administrative fees. Academic Learning Company dba Velazquez Press, Brain Hive (PDI Education LLC), Cambridge University Press (The Chancellor, Masters, and Scholars of the University of Cambridge), Gretchen Bernabei, Trail of Breadcrumbs LLC, and Practicing Musician were removed from award for failure to submit insurance as per the bid terms.
