Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found below. ACP Direct (Affordable Computer Products, Inc.) and AssetGenie, Inc. DBA AGiRepair and AGParts Education (AssetGenie, Inc.) are awarded on a separate contract with the same products and therefore were not considered for award. Benchmark Education Company LLC, Discount PC, Istation (Imagination Station, Inc.), RTC INC, and The DBQ Project (The DBQ Company) are all awarded on previous RFPs for Technology Services and therefore were not considered. Competent Safety Products (Loera Safety Solutions LLC) and Public Health Institute did not meet the scope of work for this RFP and for that purpose were not considered. Zarco Electronic Supply, Inc. should have been considered for award and was incorrectly eliminated; Award Summary has been amended accordingly. Talavera Networks, LLC was removed from award for failure to report/pay administrative fees per the terms of the solicitation. Metova Inc, Mvation Worldwide Inc., and Specialty Bulb Co Inc were removed from award for failure to submit insurance as per the bid requirements.
