Smart It Pros Inc submitted a “No Bid” response. Fun and Function submitted a proposal however was not considered; vendor does not meet scope of work and submitted a “No Bid” response. BlueNet Technologies, Inc. and Favor Consulting Inc (Demlan Solutions) were removed from award for failure to provide insurance per the bid terms.
