Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Alliance for a Healthier Generation, Barnes & Noble Booksellers Inc., Bookelicious Inc., CELEBRATE Successful Early Learning LLC, Conover Company (Oakwood Solutions, LLC), Empower-TCASE (TCASE Services, Inc.), Hatch Inc., MegaMinds, NeuraPoints, Okapi Educational Publishing, Scholastic Inc., Summit K12 Holdings Inc, Teaching Strategies LLC (UTJ Holdco, Inc.), and The DBQ Project (The DBQ Company) submitted a proposal however were not considered, vendors are already awarded on an existing contract that is a better fit. Digital Pro Installation LLC (Olga Morales) and Solomon's Certification LLC submitted a proposal however were not awarded, vendors did not meet the minimum evaluation points. EP Technology Group LLC and Reflection Sciences Inc. submitted a proposal however were not considered, vendors are already awarded on an existing technology contract. Milton Durango Communications Consulting submitted a proposal however was not considered; vendor does not meet the scope of work. Netsync Network Solutions submitted a proposal however was not considered; vendor was terminated and is ineligible for a new contract at this time. Social Studies School Service (Nystrom Education; Good Year Books; The Center for Learning; MindSparks; The Writing Company) was removed from award for failure to submit insurance as per the bid terms. Blue360 Media LLC was awarded a recent contract and therefore removed from this bid award.
