Evaluation and award recommendation were based on 70% pricing and 30% references. Amergis Educational Staffing (Amergis Holdings, Inc.) submitted a proposal, however was not considered; vendor did not provide the requested forms per bid requirements. The Digital SLP and Youthlight, Inc. submitted a proposal, however were not considered; vendors do not meet the scope of work. TrueCare24, Inc. submitted a proposal, however was not considered; vendor is already awarded on an existing contract.
