Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Medical Supplies, Equipment, and Related Services for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. LSH Furniture, LLC (LS Office Furniture) submitted a proposal however was not considered; vendor does not meet the scope of work. Southwest First Aid and Safety Supply, Inc. updated the company name. Lilliworks Active Learning Foundation was removed from the award; when requested the Certificate of Insurance per bid requirements, vendor stated they could no longer comply. Vizocom ICT LLC (Vizocom) was removed from the award for failure to submit a Certificate of Insurance per bid requirements. When submitting sole source items, please include the proof of copyrights and patents to eliminate any delays in the evaluation and award process.
5. This solicitation is asking for a percent discount off catalog/pricelist/fee schedule. If multiple discounts are offered, please provide the minimum discount offered for all catalogs or items. Ranges are not allowed in the system.
6. Third party catalogs submitted on behalf of the vendor will not be considered.
7. Vendor agrees to promote any seasonal and/or special pricing as long as the promotions are equal or better than bid award pricing.
8. This solicitation is for routine medical supplies used in the course of performing services in the areas of nursing, diagnostics, athletics, infants, pre-K, government institutions providing for adults as well as students, and otherwise where treatments will be administered on site.
